- 13. Tickets are non-refundable and non-transferable unless otherwise determined by AANT.
- 14. Tickets are limited to a maximum of five single-day tickets to the AANT Club at the 2025 Darwin Supercars event per transaction.

# **Ticket Delivery**

- 15. Tickets will be delivered electronically within 3 business days to the email address provided at the time of booking.
