## Australian Auto Clubs x Europear 5-Day Free Rental Car Giveaway Promotion Terms and Conditions

- 1. The terms of this document, information on how to enter this Promotion, mechanics of entry and the Prize/s form part of the terms and conditions for entry into this Promotion (Conditions). Entry into the Promotion is deemed acceptance of these Terms and Conditions.
- 2. This Promotion is a game of chance. All entries have an equal chance of winning. The Promoter's decision is final (subject to oversight of a scrutineer if required by applicable laws) and no correspondence will be entered into with losing and/or ineligible Entrants.
- 3. The competition will have Six (6) Prize Winners, One (1) winner from each respective Auto Club, will receive a 5-day complementary car rental for travel within Australia before 31 October 2026.
- 4. The 5-day complementary car rental is inclusive of the base rate and taxes, and does not include any optional extras or ancillary items added to the booking including but not limited to: additional driver, young driver fees, car seats, premium insurance options, damages, tolls or infringements.
- Entry is only open to Australian residents who are members of the participating clubs: RACV, RACQ, RAA, RAC, AANT, and RACT. Entrants must be over the age of 21 years old to enter the Promotion.
- 6. Employees and their immediate families of CLA Trading Pty Ltd (trading as Europear Australia) ("The Promoter"), Australian Motoring Services, RACV, RACQ, RAA, RAC, RACT, AANT and their associated agencies are not eligible to enter.
- 7. The Promotion commences on Saturday 1 November 2025 at 00:01 (AEDT) and concludes on Sunday 30 November at 23:59 (AEDT) ("Promotional Period").
- 8. Entrants will be automatically entered into the Promotion for their respective club draw prize when they book a Europear rental car at https://www.europear.com.au/en-au/p/partners/auto-club-members or via the respective RACV, RACQ, RAA, RAC, AANT, and RACT car hire webpages during the Promotion Period for a car rental pick up by 1 December 2025.
- 9. Any entry that is made on behalf of an Entrant by a third party will be deemed invalid.
- 10. There is no limit of Entries per Entrant for the duration of the Promotion Period.
- 11. The Promoter reserves the right to request that an Entrant or Winner provide proof of identity, proof of age, proof of residency and/or proof of entry validity in order to claim a Prize. Proof of identification, residency, age, relevant auto club membership and entry considered suitable for verification is at the discretion of the Promoter. In the event that a Winner cannot provide suitable proof, the Winner will forfeit the Prize in whole and no substitute will be offered.
- 12. Entries must be received by 23:59 (AEDT) on Sunday 30 November at 23:59. The time of the entry will in each case be the time the entry is received by the Promoter. The Promoter accepts no responsibility for any late, lost or misdirected entries for any reason. If the promotion entry Car Rental booking is cancelled or refunded at any time then the corresponding entry or entries will be deemed invalid. The Promoter accepts no responsibility for any late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence whether due to error, omission, alteration, tampering, deletion, theft, destruction or otherwise including those entries not received by the Promoter.
- 13. Any costs associated with entering the Promotion remain an Entrant's responsibility and may vary.

- 14. The prize does not apply to compulsory or optional extras purchased on collection. Extra charges may apply to options you select; if you do not return the vehicle to the same pick-up location, return the vehicle late, or do not return the vehicle full of fuel unless the prepaid fuel option is purchased, or if you incur infringements or use toll roads. If there is damage, theft of the vehicle, or third-party loss, you must also pay up to the standard Damage Liability Fee (DLF). Optional Damage Cover Products may be purchased to reduce your liability, but there may be no cover under some circumstances.
- 15. Europear standard age, credit card, and driver requirements apply to the prize winner. Prizes are subject to Europear's standard rental <u>terms and conditions</u>.
- 16. The 5-day car hire must occur before 31 October 2026. The prize may be forfeited if not taken by this date with no extensions or swaps permitted.
- 17. The total prize value is \$2400.00 (including GST).
- 18. Prizes cannot be transferred and cannot be redeemed for cash.
- 19. All prize values are correct as at 31 October 2025 and are reflective of the recommended retail price and are in Australian dollars (AUD). The Promoter takes no responsibility for any variations in the prize values.

- 21. Each valid entrant who has entered the Promotion over the duration of the Promotional Period will be entered into the winner determination. - 22. Prizes will be awarded to the account holder of the entry mechanism used to submit their entry.
- 23. The prizes must be claimed via email by 13:00 (AEDT) on Wednesday 17 December 2025. An unclaimed prize winner determination will take place at Europear Australia, 189 South Centre Road, Tullamarine, Victoria 3043 at 13:00 (AEDT) on Thursday 18 December 2025. The Unclaimed Prize Winners will be notified in writing within two (2) days of the unclaimed prize winner determination.
- 24. If any particular winner determination is scheduled on a Public Holiday, the winner determination will be conducted on the following business day.
- 25. Should an Entrant's contact details change during the Promotional Period, it is the Entrant's responsibility to notify the Promoter. A request to change or modify any information provided in an entry should be directed to the Promoter.
- 26. The Promoter's decision is final, and the Promoter will not enter into correspondence regarding the Promotion result.
- 27. It is a condition of accepting the prize that the Winners must comply with all of the conditions of use of the prize and the Prize Supplier's requirements.
- 28. In the case of the intervention of any outside act, agent, or event which prevents or significantly hinders the Promoter's ability to proceed with the Promotion on the dates and in the manner described in these Terms and Conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism, the Promoter

- may in its absolute discretion cancel the Promotion and recommence it from the start on the same conditions.
- 29. The Promoter shall not be liable to any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any prizes except for any liability which cannot be excluded by law.
- 30. The Promoter is not responsible for any incorrect or inaccurate information, either caused by the user, or for any of the equipment or programming associated with or utilised in this Promotion, or for any technical error, or combination thereof that may occur in the course of the administration of this Promotion including omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.

The Promoter reserves the right in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.
