

Car Insurance through AANT - \$1,000 Fuel Voucher Competition Terms and Conditions

Promotion name

Promoter

Promotion period

3. The Promotion commences at 9:00am (ACST) on 4 May 2026 and ends at 5:00pm (ACST) on 29 May 2026 ("Promotion Period").

Eligible Policy

4. An Eligible Policy is any new Car Insurance policy (including Comprehensive Plus, Comprehensive, Comprehensive Basics, Third Party Property Damage, and Third Party Fire & Theft) that has not been insured under a CGU policy for the same vehicle within the past 90 days, is purchased through AANT, and commences during the Promotion Period.

For clarity, an Eligible Policy does not include:

- policy renewals; or
- policies cancelled within 30 days of the policy start date
- Employees of the Promoter, including their immediate family members, are excluded from participating in this competition.

Eligibility to enter

5. To be eligible to enter the Promotion, you must:
 - A) During the Promotion Period:
 - be a resident of the Northern Territory;
 - be 18 years of age or older;
 - apply through AANT for an Eligible Policy;

 - not have held a CGU policy for the same vehicle within the past 90 days.
