

## AANT Centre Golden Ticket Competition

### Terms and Conditions

1. The promoter is the Automobile Association of Northern Territory Inc ABN 13 431 478 529 of 2/14 Knuckey Street, Darwin NT 0800, Australia (the Promoter, AANT).
2. Information on how to enter and eligibility to be entered into the draw and prize details form part of these terms and conditions. Participation is deemed acceptance of these terms and conditions.
3. This promotion offers AANT Members the chance to win one (1) **AANT Centre Golden Ticket**, entitling the winner to twelve (12) double passes (24 tickets in total) over a twelve-month period to eligible performances at AANT Centre.
4. The promotion period begins at 12:00AM (ACST) on September 1, 2026 and ends at 11:59PM (ACST) on October 31, 2026.

### Ticket Redemption

9. One (1) winner will be selected at random and notified via phone and/or email. The draw will take place at 2/14 Knuckey Street, Darwin NT, on November 2, 2026.
10. The winners' contact details may be shared with the relevant event organiser or ticket provider to facilitate ticket distribution.
11. The prize consists of twelve (12) double passes (2 tickets) to eligible AANT Centre performances, valid for twelve (12) months from the date the Golden Ticket is issued. The winner may redeem one (1) double pass in each calendar month during the validity period for an eligible performance, subject to availability. A calendar month means the period from the first to the last day of each month. Each redemption includes admission for the winner and one accompanying guest.
12. To redeem a monthly double pass, the winner must contact AANT Centre's Box Office at least seven (7) days prior to their chosen performance. Ticket redemptions are subject to availability. If a performance

is sold out or Venue allocated tickets are unavailable at the time of booking, the Golden Ticket cannot be redeemed for that performance. Seating will be allocated by AANT Centre at the time of booking, and requests for specific seats cannot be guaranteed. Requests received fewer than seven (7) days before a performance may not be accommodated.

13. Each monthly double pass may be used only once. Once tickets have been issued for a selected performance, that month's double pass cannot be exchanged, transferred or carried forward. Any unused monthly double pass expires at the end of that calendar month.
